THURSDAY, MAY 2, 2024

8:00am Opening Ceremony and Plenary

This session will provide a general introduction to the conference and highlight the critical role attendees play in keeping our communities safe! Law enforcement leaders will provide an overview of how to combat violence and protect our communities.

12:00pm From Enforcer to Guardian: Embracing a Service-Based Approach to Law Enforcement

During this session, presenters will share innovative and proven methods of instilling a service and customer-focused ethos within a public-facing organization. Branding, Marketing, and Customer Satisfaction executives from some of America's most trusted brands will discuss strategies to build trust, foster loyalty, create goodwill, and amplify positive and unifying stories. Participants will explore the origins of law enforcement officers as 'guardians vs. warriors' in their communities and the concept's relevance to public safety today. 12:00pm Engaging Your Critics

Proactively reaching out to community organizations and leaders who have been critical of law enforcement is a difficult but necessary task. Simply ignoring dissenting voices or waiting until a challenge or controversy arises to engage them, are risky approaches that do not foster healthy community relationships. This session will emphasize working together to educate and inform each other and building relationships together to prioritize communication over conflict and build a solid foundation for the community-police relationships that are so crucial - especially when navigating times of controversy and high stress. Attendees will learn best practices for engaging your agencies' critics and holding constructive dialogue that leads to long-term relationships.

7:00pm Connecting to our Colleagues: Building the Community of Practice

An important goal of the PLECET Conference is building strong professional networks; this session is aimed at just that. This is an off-site and largely social networking event with live entertainment, casino games, southern food, dancing, cigars, bar, and more. It will include an introduction and overview of the new Law Enforcement Community Engagement Network and will provide ample opportunity for meeting and learning from colleagues from across the nation. 9:00am The 2024 Torch Awards

The Torch Awards recognize influential public figures who carry forward the torch of servant leadership and the spirit of service and nonviolent social change that the Reverend Dr. Martin Luther King Jr. and his cohorts embodied. While icons of the Civil Rights Movement of the 1950s and 1960s are rightly celebrated for their historic work to create a better world, each generation must produce its own leaders who forge justice. Mrs. Coretta Scott King often said, "Freedom is never really won, you earn it and win it in every generation." For that reason, the Torch Awards recognize the contributions of national leaders born after April 4, 1968, the tragic day when Dr. King was assassinated on the balcony of the Lorraine Motel in Memphis, Tennessee.

This session will offer a rare and historic opportunity for attendees to dialogue with two surviving members of Dr. King's inner circle. A special discussion will be co-hosted by Ms. Xernona Clayton and The Hon. Andrew Young, both of whom are revered civil rights icons and former top aides to Dr. King.

Each year, the Torch Awards honor prominent individuals who contribute to a better world in one of the following categories: Advocacy, Arts, Business, Civil Rights, Criminal Justice, Education, Entertainment, Government, Health, Law, Media, Philanthropy, Public Safety, Science, Sports, and Technology. By honoring recipients from all walks of life who light the way to improving humanity, the Torch Awards celebrate torchbearers building the "Beloved Community" that Dr. King, Ms. Clayton, Ambassador Young, and their counterparts envisioned - in communities of every kind.

This year's honorees are exemplary national leaders in the areas of public safety and criminal justice.

1:00pm Community Service Projects

Conference attendees will participate in community service projects at seven sites across the Atlanta area on Saturday, May 4 in partnership with prominent local non-profits, increasing conference visibility and fostering positive interaction between PLECET conference attendees and partners, local civic and community leaders, and law enforcement in service to the community at large.

SUNDAY, MAY 5, 2024

9:00am State and Regional Caucuses

The State and Regional Caucuses will provide an unprecedented platform for law enforcement-community engagement practitioners to connect, exchange ideas, and develop strategies alongside their colleagues on a state and regional basis to enhance community engagement efforts. The session is dedicated to fostering collaboration and unity in the field and attendees will have the chance to come together with their peers from the same state and the same region, creating a forum for ongoing dialogue and collaboration. Participants will explore ways to leverage collective strengths, address common challenges, and share best practices for building trust and rapport.

^{10:30am} Closing Ceremony and Conferral of Training Certificates

This closing session will mark the culmination of several days of intensive learning, collaboration, networking, and inspiration, as dedicated law enforcement professionals from across the country come together to deepen their commitment to community-focused policing.

Central to the Closing Ceremony is the conferral of training certificates which will reflect the specific number of hours each attendee spent doing classroom training, seminar training, networking, and community service. Attendees are encouraged to submit their training certificates to the peace officers' standards and training council/authority in their respective states.

Thriving Together: The Wellness Equation for Law Enforcement & Community

Proactive engagement, communication, and problem-solving are key to fostering effective law enforcement - community relationships. Healthy law enforcement personnel and organizations are necessary to execute these critical tasks. The field cannot attract and retain personnel, build relationships with their communities, or sufficiently keep their communities safe without ensuring the wellness of their people. During this session, panel members will explore the intersection of wellness, police culture and organizational health, recruiting and retention, diversity and inclusion, and community engagement. Attendees will walk away with useable information on how to foster healthy personnel, police organizations, and community relationships.

Beyond Buzzwords: Demystifying Community Engagement in Law Enforcement

Community engagement is a related but distinct concept from other community-focused terms and concepts. During this session, presenters will discuss the definition of community engagement and what it means for law enforcement personnel assigned to community engagement roles. The session will highlight the differences between community engagement, community outreach, community intervention, community events, and community policing. Session presenters will provide instruction on the fundamentals of engagement; creating a results-oriented engagement strategy; and how it relates to, and often complements, events, outreach, enforcement, strategy, and communication. Finally, the session will focus on practical, innovative community engagement practices from agencies across the country.

Creating Connections: Designing High-Impact Law Enforcement Events

This training will offer instruction on strategic creation or selection of community events for your agency - to host or to participate in based on public safety priorities. Presenters will examine best practices for event planning and organization; strategic cultivation of event partnerships; managing logistics; and communicating before, during, and after the event for maximum impact. The session will provide a deep dive into categories of events and offer specific examples. Training will also review the fundamentals of securing funding from police foundations, businesses, private foundations and other stakeholders.

Bridging the Divide: Using Contact Theory to Build Trust with Communities

This session will provide instruction on integrating the tenants of Intergroup Contact Theory into community engagement efforts. Intergroup Contact Theory states that through meaningful, institutionally supported collaborative interactions between members from different social identity groups, prejudice can be decreased. Presenters will provide an overview of the theory and supporting research and will offer guidance on how it can inform community engagement and methods for collaboration with various perspectives, backgrounds, and ideologies of all stakeholders. This session will focus particularly on working in communities that have historically had distrustful or distant relationships with law enforcement. Speakers will provide practical guidance on ways to lean into community dissent; hold constructive conversations; and build relationships that have a foundation of respect.

The Multi-Channel Mix: Mastering Media for Positive Outcomes

Session attendees will hear from communications experts who will explore the use of social and traditional media resources as part of law enforcement agencies' community engagement strategy. Whether your agency has a designated communications unit or a single public information officer, community engagement is a vital part of the organization's communications strategy. Conversely, strong communication is vital to effective community engagement. This session will highlight messaging through diverse media platforms to convey honest and transparent public safety information to bolster trust and support relationships with your community.

From CAD to Community: Mastering Data to Tell Your Agency's Story

Finding ways to tell your agency's story to the community is critical. Using data, statistics, and storytelling provides valuable and compelling performance and impact information to stakeholders. During this session, speakers will present information on tracking, compiling, analyzing, and presenting information that tells your agency's story. From the importance of using Computer Aided Dispatch (CAD) systems to track and measure effectiveness to establishing meaningful ways present data and information to stakeholders, this training will help even the most non-technical attendee better understand and use data to support community engagement efforts.

From Pulpit to Precinct: Practical Steps for Building Law Enforcement-Faith Partnerships

Faith-based organizations and leadership usher genuine connections and communication with diverse segments of every community. They also provide faith-based support for the law enforcement family. This session will focus on partnering with faith-based organizations, including aligning priorities, communicating effectively, managing conflict, supporting each other, and fostering long-term trusting relationships. Speakers will focus on practical steps and partnerships that are working in communities across the nation today.

How Can I Help? Are you Okay? Introducing 'Make the RIGHT Choice and Intervene' Training

Use of force has long been a topic of national discussion, especially when a high-profile case heightens community tension. It is a complex issue that includes policies and procedures, training and education, community awareness, accountability measures, leadership, investigations, outreach, and data collection, reporting, and analysis. The Office of Community Oriented Policing Services (COPS Office) with IACP and IADLEST developed training to empower officers to intervene to prevent colleagues from commutity frust with the ultimate goal to improve community and officer safety. This session will provide a training module from the 8-hour duty to intervene/active bystandership training.

From Siloed to Strategic: Building a Unified Community Engagement Culture

This training will focus on building an internal culture of community engagement throughout a law enforcement agency, including securing buy-in and garnering support. Effective community engagement requires a strategy of holistic, agency-wide integration rather than what has historically been assigned to a one unit, individual, or activity with limited resources or support. Speakers will provide an overview of research, strategies, and outcomes that serve as a catalyst for organizational change toward making community engagement a department-wide priority.

Disrupting Cycles of Violence: A Workshop on Evidence-Based Intervention Strategies

Community Based Violence Intervention and Prevention (CBVIP) programming uses evidence-informed strategies to reduce violence through tailored community-centered initiatives. This session will instruct attendees on multidisciplinary strategies that engage individuals and groups to prevent and disrupt cycles of violence and retaliation and establish relationships to deliver services that save lives, address trauma, provide opportunity, and improve the physical, social, and economic conditions that drive violence. Presenters will use research to support the need for and outcomes of this work.

Innovation Incubator: Cultivating & Sharing Successful Community Policing Strategies

This will be a working session that sets the stage for sharing ideas between PLECET conference attendees. Working in small groups, participants will share and expand on current programs that are successful in their communities. They will discuss ideas for new, innovative future initiatives and will come away with something they can implement in their own agency or community that was successful in another. Come prepared to share and learn from your colleagues!

Evolving Together: Meeting Community Needs Through Continuous Innovation

With an eye toward the future, this session will focus on ways to encourage and implement innovative approaches to working with communities. In a time of ever-increasing division across the nation, and ever-decreasing numbers of law enforcement officers to do this important work, how do agencies change the dynamic of police and community relationships toward one of true collaboration? Presenters will discuss technology and innovation that promises to revolutionize how police and communities work together to foster truly collaborative relationships, and strategies to continually evaluate and innovate to meet our communities' changing needs.
